While there are some other limitations, Safeco will insure most watercraft up to 40 feet in length and \$300,000 in value and most watercraft with a maximum speed of 65 mph (85 for bass boats).

WHAT WE COVER

Vehicles that are used for recreational purposes, such as motorhomes, travel trailers, fifth wheels, toy haulers, folding camping trailers, truck mounted campers, utility trailers, horse trailers (with or without sleeping quarters), professional bus conversions and some toterhomes.
